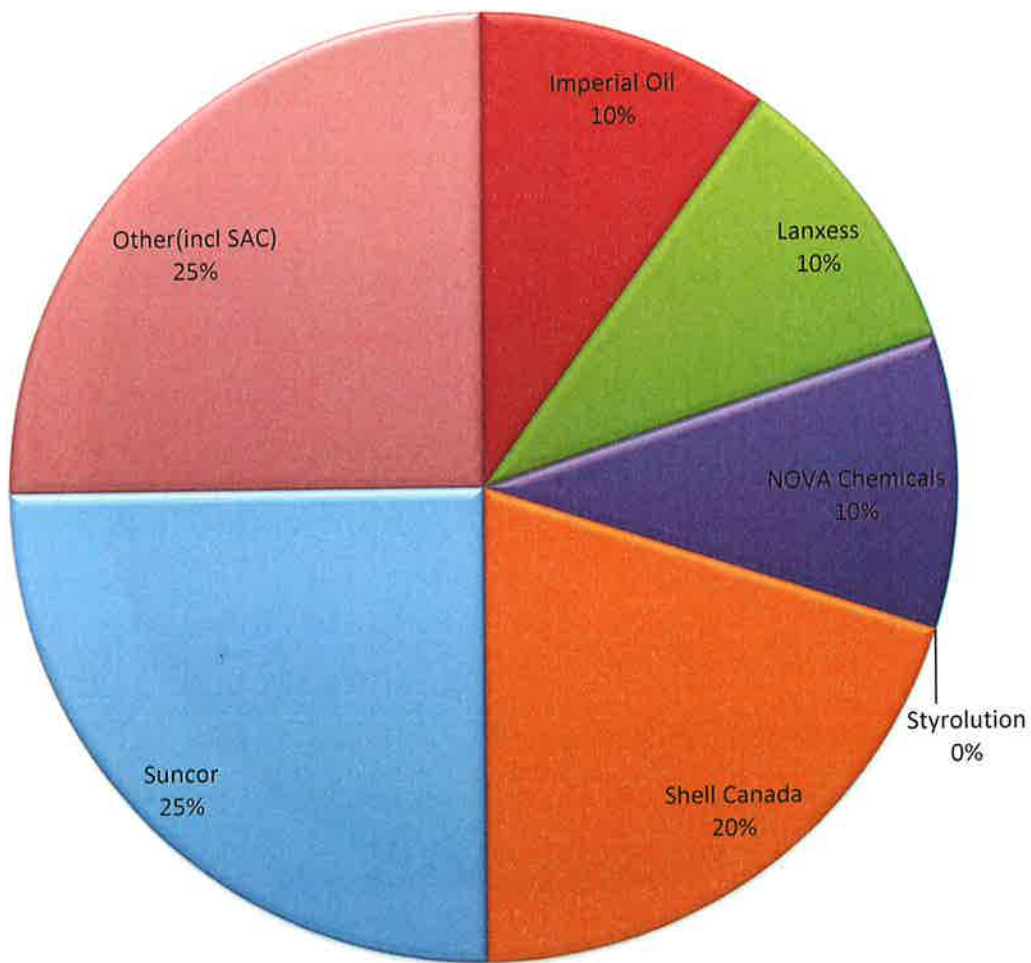

Percentages of Incident Notifications Occurring in the Month of August 2015

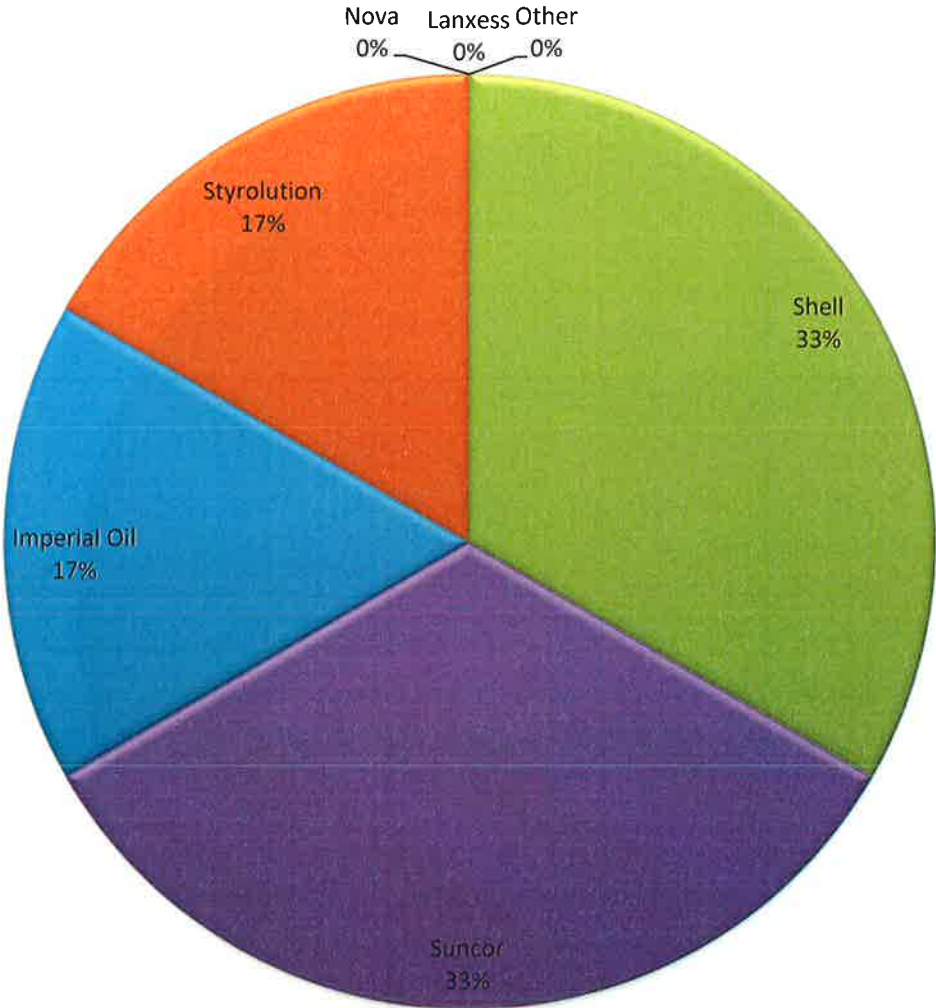

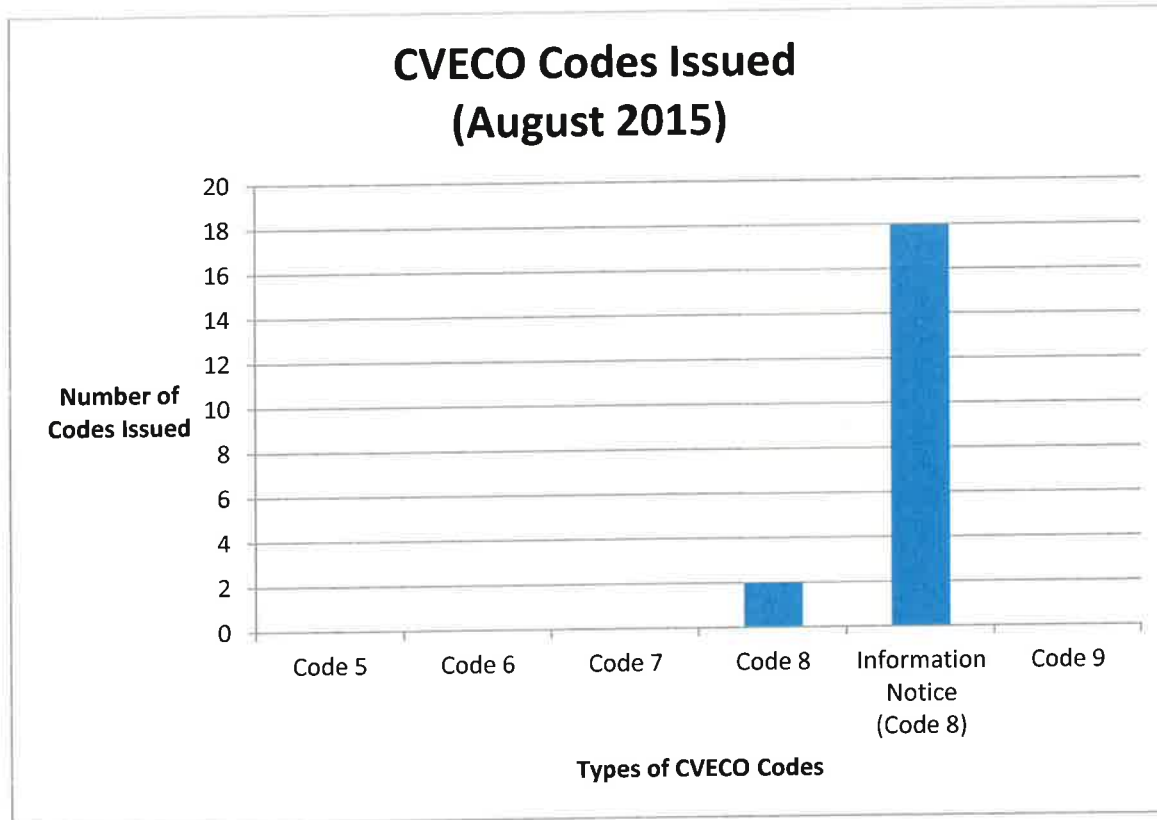
Percentages of Proactive Notifications for the Month of August 2015

CVECO Assistance Codes:

CODE 5- Incident outside of industry potentially requiring CVECO assistance.

CODE 6- Full traffic control requested in designated areas.

CODE 7- Bomb threat.

CODE 8- Notification by a CVECO member of an internal emergency occurrence. CVECO will take no action under this code.

Information Notice - Advice by a member of a non-emergency activity that may cause an inquiry.

CODE 9- Request for response by Municipal Fire Department.
