1. Background

The Aamjiwnaang Education Department has a mandate to provide a broad range of advisory and information services, technical and administrative support, and coordination of regional initiatives for Aamjiwnaang members.

Aamjiwnaang Education Department is governed by the Education Committee appointed by the Aamjiwnaang Council. As it relates to Post-Secondary Education Program, the duties and responsibilities of the Education Committee are:

- To provide input to the Manager of Education Aamjiwnaang concerning the overall management of the Program.
- To annually review the student assistance policy.
- To provide guidance to program staff in the review, evaluation, and/or development of recommended revisions to First Nation specific programs provided by the local colleges and universities.
- To review quarterly reports provided by the Post-Secondary Counsellor and staff of the Post-Secondary Education Program.
- To review and approve the three yearly intake submissions (March 1, and May 1, October
 presented by the Manager of Education and the Post-Secondary Counsellor.
- To review student appeals; as directed by the Manager of Education.

2. Introduction to the Post-Secondary Program

The mission of the Aamjiwnaang Education Department is to assist eligible member in their pursuit of higher educational opportunities. We strive to enrich the experience of the student by supporting and advocating while they are on their academic path to self-empowerment.

The goal of the Post-Secondary Program is to continually increase the number of student graduates, while maximizing the limited funds in accordance with funding guidelines, to enrich oneself, their family, and-our Nation.

The Post-Secondary Program objectives are to improve communications, develop student skill sets, and strengthen partnerships for the continual success of our present and future generations in the following manner:

Improve Communication

- Increase communication to and from students through student contracts, social media, and counselling sessions.
- Strengthen communications with Aamjiwnaang, Education staff and outside educational institutions through information sessions, annual open-house, and other outreach activities.

Develop Learner Skill Sets

 To be responsive to student needs by establishing rapport through a minimum of twice per semester counselling sessions.

- Encouraging students to access educational institution supports that increase their skill set.
- Locating and developing workshops for students to attain the necessary skills to be successful in their education.

Strengthen Partnerships

Develop partnerships with the local Post-Secondary Institutions by having representation on the Indigenous Education Councils to advocate for students and advise on initiatives, research, community resources, academic programming, and oversight of services.

3. Introduction to the Student Assistance Policy

This document outlines the Aamjiwnaang Post-Secondary Financial Assistance Policy.

The Objectives of the Post-Secondary Program Student Assistance Policy are to:

- Establish the criteria to be met by students in order to qualify for and maintain eligibility for financial assistance.
- Outline the types and maximum levels of allowances that may be available.
- Provide assistance with respect to various levels of post-secondary education.
- While receiving financial assistance students are obligated to make their education studies a top priority and to ensure they are achieving an acceptable Grade Point Average (GPA).

4. Definitions

In this document:

"Aamjiwnaang Council" means the executive decision-making body made up of the Chief and Councillors of Aamjiwnaang selected in accordance with the election process used by Aamjiwnaang.

"Academic Year" is as defined by the post-secondary institution but will not be less than eight months duration.

"Accessibility Services" is defined as providing supports and services to students with documented disabilities.

"Anishinabek Education System" The Participating First Nations (PFN) under the Anishinabek Education System (AES) will enact education laws that govern the AES and the delivery of programs and services.

"Academic Jeopardy" is defined as a student who has a grade point average below 2.0 and at risk of not being in good standing.

"Canadian public institution" is a post-secondary institution which receives the majority of its funding from federal and provincial governments.

"CEGEP" is an abbreviation of College d'enseignement general et professionnel. CEGEPs operate in Quebec.

"Community Integration through Cooperative Education (CICE)" is a post-secondary program, predominantly found at Ontario colleges, designed for students with intellectual, developmental, or other learning challenges to develop essential academic, life, and vocational skills for increased independence and community participation

"Course months" are defined as the number of months required to complete a program or course of study.

"Co-op education" is defined as program which alternates periods of academic study with periods of work experience for which the student receives remuneration from the employer.

"Distance Education" is defined as the education of students who may not always be physically present at a school.

"Delivery Mode" is the format in which a program is delivered.

"Education Committee" is made up of 2 Councillors, 3 community members and 1 Youth Council representative. They meet on the 2nd and 4th Wednesday of the month.

The committee's term is 2 years and members are chosen by Chief and Council.

"Education Department" Responsible for the delivery of education programs and services.

"Eligibility" has met the criteria for application and is an approved, accepted student in the Aamjiwnaang Financial Assistance Program.

"Extenuating circumstances" are unplanned events of a significant nature such as medically diagnosed condition or illness, death in the family or accidental injury. Extenuating circumstances does not include ceremonies or religious practices.

"Family" – is defined as a student's spouse, child(ren), siblings, parents, grandparents, aunts, uncles, and their spouse's child(ren), siblings, parents and grandchildren.

"Field placement/Practicum" is defined as an opportunity to gain vital work experience, develop professional contacts within the industry, and enhance your résumé while studying. It is typically an unpaid position.

"First Nation" shall have the same meaning as "Band" defined in the Indian Act.

"Fiscal year" is April 1 to March 31 annually.

"Free Application for Federal Student Aid" – Federal student aid comes from the federal government – specifically the U.S. Department of Education. It is money that helps a student pay for higher education expenses (i.e. college, career school or graduate school expenses). Federal student aid covers such expenses as tuition and fees, room and board, books and supplies and transportation. Aid also can help pay for a computer and for dependent care. There are three main categories of federal student aid; grants, work-study and loans. Check with your school to find out which programs your school participates in. Website information www.fafsa.gov.

"Foreign Institution" is any post-secondary institution located outside of the geographic boundaries of Canada.

"Full-Time Students" must be enrolled in a minimum of 60 percent unless a student qualifies for a reduced courseload through the institutions accessibility service department.

"Grade point average" is the grade assigned to the student by the post-secondary institution of registry for the average graded achievement of all courses undertaken in an academic year. Where a grade point average is assigned by the institution, they will do the equivalency conversion to A, B, etc.

"Internship" is defined as an opportunity offered by employers to students interested in the industry. Internship may be paid or unpaid; if paid, living allowance will be adjusted accordingly.

"Intensive mode programs" are defined as programs that are delivered continuously over a short period of time.

"Mature Student" is defined as a person over the age of 20 and who has been out of school for at least two years and meets all other eligibility criteria in this policy.

"Online programs" refers to programs that are delivered electronically.

OSSC

"Ontario Secondary School Diploma (OSSD)" refers to the secondary school diploma obtained in Ontario.

"Part-Time Students" are defined by the Part-time students may receive assistance for tuition and compulsory fees and the \$150 of books and supplies, per course but are not eligible for a living allowance.

"PELL Grants" usually are awarded only to undergraduate students who display exceptional financial need and have not earned a bachelor's, graduate, or professional degree.

"Post-Secondary Team" is a staff employed by Aamjiwnaang and work within the Education Department for the delivery of this program.

"Post-secondary education" means a program of studies, offered by a post-secondary institution, for which completion of secondary school studies or equivalent is prerequisite.

"Post-Secondary Institutions" are degree, diploma, and certificate granting institutions which are recognized by the province of Ontario, and include education institutions affiliated with, or delivering accredited post-secondary programs by arrangement with a post-secondary institution.

"Private post-secondary institution" is a post-secondary institution which receives the majority of its funding from the student fees, and from sources other than governments.

"Program of Studies" includes all post-secondary programs leading to a certificate, diploma, or degree. For the purposes of this policy, the program of study is divided into the following categories:

- Level 1: University/College certificate programs (8 months to 1 year)
- Level 2: Community College and CEGEP diploma or certificate programs (1-2 years)
- Level 3: Undergraduate Degree programs
- Level 4: Advanced or professional degree programs
- Level 5: Doctoral programs

"Pro-rated" is defined as the division of monthly living allowances into weekly amounts.

"Registered member" means a person whose name has been entered on the First Nation membership roll and in the Indian Register Maintained by Indigenous Services Canada as defined by the Indian Act.

"Scholarship" refers to financial support to a student's education, awarded on the basis of academic or other achievements.

"Semester" /term refers to a part of the academic year, as defined by the post-secondary institution. Semesters usually cover the periods from (fall) September to December, (winter) January to April, and (spring/summer June/July/August. May to August.

"Student" is defined as a full- or part-time post-secondary student sponsored by the Aamjiwnaang Post-Secondary Financial Assistance Program.

"Textbooks and supplies" are defined as: textbooks identified by the school/course list as necessary for the course. Supplies include items such as: pens, pencils, paper, binders, notebooks and other supplies as defined in the course outline.

"Ticket" is defined as the number of times a student is eligible for sponsorship by the Post-Secondary Program, in a certificate, diploma, or degree in a post-secondary program. "First Ticket" is defined as the successful completion of a program of studies and receiving of a certificate, diploma, or degree. "Second Ticket" is defined as studies in another program field, pursuing graduate studies, or a change in a career focus that can be unrelated to the first ticket program of studies.

"Waitlisted student" is an eligible student who applied late.

5. Eligibility

5.1 To be eligible to apply for assistance under the Aamjiwnaang Post-Secondary Financial Assistance Policy applicants:

- a. Must provide proof of being registered members of Aamjiwnaang First Nation.
- b. Must possess a grade 12 secondary school diploma, secondary certificate or its equivalent and have met university or college requirements. As well, students who have previously received certification from a government recognized educational institution such as CEGEP or an ACE/GED programs are eligible.
- 5.2 Within the limits of funding received by Aamjiwnaang, through contributions from AES, the Post-Secondary Program may provide financial assistance through the following priority allocation system:

Student priorities may change based on academic achievement.

5.3 The Post-Secondary Program does not apply restrictions for eligibility based on age, terminal illness, or learning disabilities.

6. Types of Assistance: Full-Time Students

- 6.1 Tuition Assistance includes student's fees for registration, tuition, and the cost of books and supplies which are listed as required by the program of study in the post-secondary institution. Tuition is always paid directly to the institution when possible.
- 6.2 Tuition assistance may be provided:
 - a. For students attending Canadian public institutions, at the normal rate in Canadian dollars charged by the institution for a Canadian student.
 - b. For students attending Canadian private post-secondary institutions where a comparable program is offered by a Canadian public post-secondary institution, at the normal rate in Canadian dollars as charged by the Canadian public institution nearest to the student's place of residence at the time of application.

- c. For students attending Canadian private post-secondary institutions where no comparable program is offered by a Canadian public post-secondary institution, at the rate in Canadian dollars as charged by the Canadian private institution.
- d. High-Cost Tuition Fees: students are encouraged to seek out less costly but similar programs, all tuition fees exceeding \$10,000 Canadian funds per annum will be subject to the Education Committee approval.
- e. For students attending a foreign public post-secondary institution, where no comparable program is available in Canadian public post-secondary institution, at actual rates in the appropriate currency. (Refer to 6.15).
- f. For students attending a foreign private institution, where no comparable program is available in Canadian public/private post-secondary institution, tuition will be paid at actual rates in the appropriate currency.
- g. For students attending foreign public and/or private post-secondary institutions where a comparable program is offered by a Canadian public post-secondary institution, at the normal rate in Canadian dollars as charged to a Canadian student by the Canadian public institution nearest to the student's place of residence at the time for application (refer to 6.15) for maximum payable amounts
- h. In the case of a First Nation Post-Secondary Institution, the tuition fees will be those normally charged to students attending a comparable program at a nearby provincial institution.
- i. PhD student funding will be based on financial need. Doctorate students must provide financial and/or grant information to their assigned counsellor.
- j. All financial assistance is based on availability of funds.

6.3 Travel Assistance:

- a. All travel costs are at the expense of the student including relocation expenses.
- b. Conference Funding: Students may be eligible for funding that includes registration fees and travel expenses to attend conferences and school trips that are mandatory and directly related to their program of studies by being a part of the regular curriculum which must be supported with a letter of recommendation from their instructor. All mandatory conferences must be known at the start of the program and communicated to their counsellor. Students must provide their counsellor with a written report and expense receipts upon return.
- 6.4 Assistance for Living Expenses: Living allowances to help cover students living expenses may be provided at a rate not to exceed that established by Education Department in consultation with the Education Committee from time to time. The current rates, with last change date, are attached as listed in section 17. Living allowances are in Canadian funds.
- 6.5 Residence Expenses: Students considering residence sponsorship must indicated so on their post-secondary financial application. Students must apply directly to their institution's residence and once accepted must provide a letter of acceptance from the institution. The Aamjiwnaang Post-Secondary Financial Assistance Program will cover the maximum eligible living allowance. Fees above the allotted living allowance will be at the cost of the student.

- 6.6 Co-op, Internship, practicum Field Placements: Students who are on co-op semesters and being paid by the employer will not be eligible for living allowances unless the monthly wage is less than that offered monthly by the Aamjiwnaang post-secondary program. If the amount is less than \$1200 per month Aamjiwnaang will supplement the difference up to \$1200. Students who are on unpaid internships and field placement may be eligible to receive assistance for living allowances.
- 6.7 Exceptional Assistance: Exceptional assistance for legally or institutionally required activities for initial professional certification or licensing fees may be provided as well as special testing fees as determined by the program requirements.
- 6.8 Intensive mode programs: students will be eligible to receive financial assistance with the payment of tuition fees, textbooks and supplies, and pro-rated living allowance.
- 6.9 Ineligible Assistance: Correspondence programs and Internet programs offered by private institutions will not be funded.
- 6.10 College and University base application fees will be paid or reimbursed by the Aamjiwnaang Education Department up to a maximum of \$200.00. Application fees include OCAS, OUAC, and base applications for Master, PhD's, Teacher's College, Law School or Medical school. Based on availability of funding.
- 6.11 Extension fees for online course work will not be covered.
- 6.12 High-cost Equipment Purchases: High-cost equipment purchases such as computers, cameras, musical instruments, culinary supplies and etc., requires documentation from the college or university that the purchases are a necessary part of the program. If a student fails to complete their program of studies, all high-cost equipment purchases become property of Aamjiwnaang Education Department and must be returned immediately; as per Aamjiwnaang Property Form. Failure to return equipment to the post-secondary program will affect future assistance eligibility.
- 6.13 Special Needs Purchases: Special Needs Equipment purchase requests such as computers, readers, scanners, etc. requires documentation from Accessibility Services at the student's institution. The student must provide a copy of their IEP documentation that identifies their learning disability. If a student fails to complete their program of studies all special needs equipment becomes the property of Aamjiwnaang Education Department and must be returned immediately.
- 6.14 Books and Supplies Assistance: Support for books and supplies for a student's program of studies.
 - \$400 per semester for full-time college students
 - \$800 per academic year for full-time university students.
 - \$150 per course for part-time students (up to 2 courses)

An amount in excess of \$800, per school year may be approved if a student demonstrates need by submitting copies of the course outlines and the prices charged by the institution's bookstore or suppliers.

Book allowances will not be paid to students who are retaking a course for which they previously received funding for.

Receipts should be submitted within the fiscal year.

- 6.15 For a student enrolled in community college or CEGEP diploma or certificate program, or an undergraduate university program, the maximum amount payable per full-time student under the post-secondary program cannot exceed \$35,000 per year. On an extraordinary and justified basis, the maximum amount payable per year for a student in an advanced or professional degree program (e.g. dentistry, medicine) or a Masters or Doctoral program may exceed \$35,000 up to a maximum of \$50,000. Such awards may be granted by special request on a case-by-case basis only and considered when a graduate student has extraordinary circumstances that warrant the setting aside of the standard policy on maximum amounts payable. The maximum amount was established to ensure that the most extreme circumstances could be funded as necessary. The actual amount of funding available to a student will depend on the overall amount of funding available in the program and for each recipient.
- 6.16 Health and dental fees will not be paid or reimbursed by the Aamjiwnaang Post-Secondary Program. First Nation citizens have health, dental and prescription drug coverage through the First Nations and Inuit Health Branch (Health Canada).
- 6.17 Students on an Individual Education Plan (IEP): Students on an IEP are to discuss it with their post secondary counsellor prior to the academic year to ensure all supports are in place before commencing the school year. Each year the student is required to revise their IEP indicating any changes and provide an outline of the academic standing achieved along with a transcript of marks.
- 6.18 Bus passes/Parking passes must apply to the Education Services Request, pending funding availability.

7. Types of Assistance: Part-Time Students

Part-time students may receive assistance for tuition and the cost of books and supplies as detailed in 6.1.

8. Limits of Assistance

8.1 Assistance may be provided for one-time sponsorship (called tickets) in each level as per the following:

Assistance may be provided at five levels of post-secondary education:

- **Level 1:** University/College certificate programs. To a maximum of two: Pre-health, pre-technology, foundational programs (1 year or 8 course months).
- **Level 2:** Community College and CEGEP diploma or certificate programs. To a maximum of two:
 - 1 year (8 course months) General Arts and Science/CEGEP or

- Community College diploma or certificate programs (1-3 years or 8 to 24 course months) or
- 2-year General Arts and Science Program for individuals entering University studies only.
- **Level 3:** Undergraduate To a maximum of two:
 - 3-4 years or 24 to 32 course months
- **Level 4:** Advanced or professional degree programs or Masters Program maximum of 1:
 - 1 to 3 years or 12 to 36 months
- **Level 5:** Doctoral programs maximum of 1:
 - 4 years or 48 months
- 8.2 Tuition assistance as outlined in 6.1 may be provided to students enrolled in all four levels.
- 8.3 Assistance for living expenses as outlined in 6.4.
- 8.4 Level 2 will include assistance for an additional student year at the bachelor level to acquire an honours undergraduate degree.
- 8.5 The duration of assistance will be in accordance with the official length of the program as defined by the post-secondary institution in which the student is enrolled.
- 8.6 Students may be assisted for up to one additional academic year per level if such an extension is approved in writing by the institution's dean or the head of department; also included will be medical or personal reasons.
- 8.7 Students may be assisted in Level 1 studies after dropping out of Level 2 studies. If a student resumes Level 2 studies, the previous time spent at Level 2 will be counted for assistance purposes. Students who have completed Level 2 studies, with or without assistance from this program are ineligible for level 1 assistance with the exception of post-diploma programs that specify BA requirements for admission.
- 8.8 Students who become eligible for assistance and who have previously completed a portion of post-secondary studies without assistance from this program may receive assistance for the balance of their program of studies in accordance with 6.2, 6.3, and 6.4.
- 8.9 Teacher Additional Qualifications Assistance may be provided for a maximum of six AQ's, up to and including two specialist qualifications.
- 8.10 -spring/summer term may be funded only when it is a regular scheduled semester for continuing students.
- 8.11 In the situation where a student attends a foreign/international post-secondary institution and qualifies to receive federal/state financial aid in the form of Pell grants, Free Application for Federal Student Aid (FAFSA), bursaries or sport scholarships, the federal/state aid will

- take precedence over the Aamjiwnaang tuition sponsorship, with the exception of work study programs and loans.
- 8.12 Students receiving funding from the post-secondary program must declare financial support received from this program.
- 8.13 The Aamjiwnaang Post-Secondary Financial Assistance Program is not responsible for repayment of student loans.

9. Processing Applications for Assistance

- 9.1 There may be three intakes for review of student applications. Students can apply online at https://afn.dadavan.com/student/pseapplication.jsp
 - spring/summer school, by March 1
 - September enrolment, by May 1
 - January enrolment, by October 1
- 9.2 Applications for assistance will be reviewed and decisions communicated to the I-email address provided by the students within 15 days of the deadline established for each session. Applications received after the deadline date are considered late.
- 9.3 Applications are approved based on priority level and availability of funds.

10. Appeals Process

To ensure fairness and equitable treatment, any student may appeal any decisions made under this policy. lack of funds does not qualify under the appeal process.

- a. All post-secondary appeals must be made in writing within (10) working days of receipt of notification.
- b. All appeals and supporting documents must be forwarded to the Manager of Education The Appeal Board shall be comprised of Education Committee members and or delegates.
- c. All inquiries related to any appeal must be directed to the Manager of Education.
- d. All decisions made by the Appeal Board must be finalized in writing within sixty (60) days.
- e. All decisions of the Appeal Board are final. A student may not appeal to Chief & Council.

11. Student Records

The Aamjiwnaang Education Department may maintain a student record record.in the Outcomes Student Information System. This information reporting aggregate data is shared for statistical reporting and will remain confidential. The Aamjiwnaang Education Department will report this information, in confidence, annually to the AES/KEB.

12. Students Not In Good Standing

- 12.1 Any expenditure made to or on behalf of a student for which that student is ineligible, places that student in a "Not in Good Standing" status within the meaning of this policy. Examples of situations are as follows:
 - a. Allowing tuition payments and/or living allowance payments to be made on their behalf where a stop payment opportunity existed and was missed.
 - b. Producing an unsatisfactory academic progress report.
 - c. Incarceration.
 - d. Giving false/invalid information
 - e. Inappropriate use of funds.
 - f. Any other reason approved by the Education Committee.
- 12.2 The Aamjiwnaang Education Department may set terms and conditions to allow students to regain their "Good Standing" status by:
 - a. Allowing the student to repay any funds paid out, value of equipment
 - b. Allowing the student to use their own financial resources to attend and successfully complete one full term or semester
 - c. To provide accurate information in question

13. Student Reviews

- 13.1 Upon the completion of each 4-month term or semester, all sponsored students will undergo an academic review to determine continued full-time financial assistance. The post-secondary team/counsellor will determine student success by the following guidelines:
 - a. 75% successful completion of the student's full-time course load.
 - b. A GPA of 2.0 (60%) or higher or the standard set by the student's program of studies will be the determining guideline for a student to be deemed in good standing.
- 13.2 Students deemed not in good standing and achieving below the standards mentioned in 13.1 above ineligible for further financial assistance. The priority designation will apply.
 - a. Academic Jeopardy Students will be issued an Academic Jeopardy letter should they fall below 2.0 and above/and including 1.5; and at risk of losing funding to a limit of 1 per program
 - b. Plan in Place Students will be issued a Plan in Place letter should they fall below a 1.5 or below. A maximum of 1 per program
- 13.3 Students who do not submit their grade reports within 15 days following the completion of each term will be deemed "not in good standing" and living allowance entitlements suspended until received and reviewed by the post-secondary department.

14. Annual Policy Review

The Education Committee will meet annually with the Aamjiwnaang Education Department to conduct a review of this policy. Any changes to the policy resulting from the review will, if at all possible, be made effective for the fall term changes will be communicated to Aamjiwnaang Council and AFN website.

15. Education Committee Right to Review Decisions

The Education Committee reserves the right to review and rescind any decision made under this policy as may be justified by new and relevant information.

17. Aamjiwnaang Post-Secondary Program

- Full-time student monthly allowance rate: \$1200.00

- Full-time book allowance is: is two payments at \$400; start of each term.
- Students will be paid in Canadian Funds
- American students must possess a Canadian bank account, in their name.
- Canadian students must possess a bank account in their name.
- Deposits are made the 2nd last business day of the month.
